

## **WIN DreamTrips Official Rules**

### **1. Eligibility**

WIN DreamTrips (the "**Promotion**") is open only to legal residents of Austria, Botswana, Canada (British Columbia and Ontario only), Cyprus, Germany, Greece, Hong Kong, Hungary, Israel, Kenya, Malta, The Netherlands, Norway, Sweden, Singapore, Slovenia, South Africa, the United Kingdom, the fifty (50) United States (including District of Columbia) and Zimbabwe who have reached the legal age of majority in their jurisdiction of residence at the time of entry and who have received an invitation to participate from a WorldVentures Representative. Void where prohibited by law. Employees, representatives, customers, and members of WorldVentures Marketing, LLC, or any of its respective affiliates, subsidiaries, advertising agencies, or any other company or individual involved with the design, production execution or distribution of the Promotion and their immediate families (spouse, parents and step-parents, siblings and step-siblings, and children and step-children) and household members (people who share the same residence at least three (3) months out of the year, whether related or not) of each such employee are not eligible and may not participate in this Promotion. The Promotion is subject to all applicable federal, state, provincial and local laws and regulations. Participation constitutes each entrant's full and unconditional agreement to be legally bound by these Official Rules and Sponsor's decisions, which are final and binding (without right of appeal) in all matters related to the Promotion to the extent permitted by law. ### **2. Sponsor**

### **3. Timing**

The Promotion begins on January 28, 2012 at 12:01 a.m. Central Standard Time ("CST") and ends on March 24, 2012 at 11:59 p.m. CST 5:59 p.m. (the "**Promotion Period**"). Sponsor is the official time keeper for this Promotion.

### **4. How to Enter**

During the Promotion Period, watch a WorldVentures presentation by invitation from a WorldVentures Representative. The presentation can be attended in person through a live meeting given by a WorldVentures Representative or viewed online at [www.windreamtrips.com](http://www.windreamtrips.com) or a sub domain of that website. The WorldVentures Representative will set the date, time and location of the live presentation. After reviewing the full WorldVentures presentation (either in person or on the internet) the entrant will be entered into the Promotion after they provide their: name, email address, phone number, age category (the "**Entry**"). The live presentation will be approximately 1 hour in length and the online presentation will be approximately 25 minutes in length. To be eligible, your Entry must be received within the Promotion Period. All eligible Entries received during the Promotion Period will be entered into the random prize draw. By submitting the Entry you agree that the Sponsor may process personal data for the purposes of the Promotion and for the duration of the Promotion, The Sponsor shall keep all entrants' personal information safe and confidential.

The Released Parties (defined below) take no responsibility and accept no liability for any lost, stolen, delayed, illegible, damaged, misdirected, late or destroyed mail-in entry requests.

**Limit one (1) Entry per person/email address during the Promotion Period, regardless of method of entry. For greater certainty, you can only use one (1) email address to enter the Promotion.** Multiple participants are not permitted to share the same email address. Any attempt by any participant to obtain more than one (1) Entry by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that participant's Entries and that participant may be disqualified (in the sole and absolute discretion of the Sponsor). Use of any automated, macro, script, robotic or other systems(s) or program(s) to participate is prohibited and will result in disqualification. On disqualification

all Entries shall be void. Released Parties (defined below) are not responsible for lost, late, incomplete, invalid, unintelligible or misdirected Entries, all of which will be disqualified. In the event of a dispute as to any Entry, the authorized account holder of the email address used to register will be deemed to be the registrant. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. The potential winner may be required to show proof (in a form acceptable to the Sponsor – including, without limitation, government issued photo identification) of being the authorized account holder of the email address associated with the selected Entry. All Entries become the sole and exclusive property of Sponsor and will not be returned. All Entries are subject to verification at any time. The Sponsor reserves the right, in its sole and absolute discretion, to require proof of identity and/or eligibility (in a form acceptable to the Sponsor – including, without limitation, government issued photo identification) to participate in this Promotion. Failure to provide such proof to the satisfaction of the Sponsor in a timely manner may result in disqualification. Entrants hereby assign to the Sponsor all worldwide copyright and like rights in Entries and waive all moral rights.

## **5. Winner Selection**

On or about February 4, 2012, February 11, 2012, February 18, 2012, February 25, 2012, March 3, 2012, March 10, 2012, March 17, 2012, and March 25, 2012, in Plano, Texas at approximately 2p.m.CST (the "**Draw Date**"), Sponsor, or an independent judging agency, will select one (1) eligible Entry for the prize described below in Section 8 in a random drawing from among all valid Entries received. On March 25, 2012 an additional selection shall take place of one additional winner. The determination of the Prize shall be monitored by a registered auditor in South Africa, a licensed Inspector in Israel and an independent judging Agency in Hong Kong. Non-winning entries from previous weeks will carry over into subsequent drawings. The selected entrant will be contacted using the email address and/or phone number provided with the Entry on the day of the relevant Draw and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these Official Rules). **FOR CANADIAN HONG KONG & CYPRIOT RESIDENTS ONLY: Before being declared as the confirmed prize winner, a Canadian, Hong Kong or Cyprus resident must first correctly answer a mathematical skill-testing question without mechanical or other aid (to be administered on the declaration and release).** Sponsor's decisions as to the administration and operation of the Promotion and the selection of a potential winner are final and binding (without right of appeal) in all matters related to the Promotion. Failure to respond to the initial attempted notification within three (3) days, or a return of any notification as undeliverable, will result in disqualification. After the winner has been verified, the Sponsor will determine which WorldVentures representative was responsible for the winning entrant's submission. That WorldVentures representative will also be declared a prize winner and also be awarded the prize described below in Section 8. Limit one prize per WorldVentures representative for the Promotion. If a WorldVentures representative has already received a prize in connection with this Promotion and later another entrant was selected as a winner who entered because of that WorldVentures representative, the prize will be randomly awarded to another WorldVentures representative.

## **7. Verification of Potential Winner**

Except residents of South Africa potential winner must continue to comply with all terms and conditions of these Official Rules and winning is contingent upon fulfilling all requirements (including, without limitation, the requirement to correctly answer a mathematical skill-testing question if the selected entrant is a resident of Canada). The potential winner will be required to sign, and return to Sponsor, by email within three (3) days of the date notice is sent by email, the Sponsor's affidavit of eligibility (declaration and release for residents of Canada) and liability/publicity release (except where prohibited) in order to claim his/her prize. Rovia Bucks will be used to book airfare to destination and associated travel expenses only subject to the terms and conditions of use of Rovia bucks available at corp.roviabucks.com. Hotel accommodations will be provided from August 1, 2012, through August 5, 2012, with check out on August 5, 2012 by 12 noon for the Mexico trip and from May 11, 2012, through May 19, 2012, with check out on May 20, 2012 by 12 noon for the Greece trip. If the winner is unable to travel during the time period for any reason, then the trip will be forfeited and no other prize will be provided. All expenses and incidental travel costs not expressly stated in the package description above, including, but not limited to, additional transportation, personal charges, security fees, taxes, excess baggage fees or other expenses or incidentals, are the sole responsibility of the winner and his/her guest (NOTE: winner may be required to present a valid major credit card in winner's name at the time of hotel check-in to cover any incidental expenses). Guest must travel on same itinerary and at the same time as the winner. Guest (and his/her parent/legal guardian if he/she is under the age of majority in his/her jurisdiction of residence) will be required to sign the Sponsor's release before going on the trip. Approximate retail value of the prize is US\$ US\$2366/CAD\$2402 for the Mexico trip and €1879 , BWP 18,002, GBP 1,564, HKD 18,644, HUF 580,708, ILS 9,203, KES 207,511, NOK 14,449, SEK16,581, SGD 3,078, ZAR 19,290 for the Greece trip. No cash equivalent for the prize will be available. The prize is non-transferable, non-assignable and no substitutions will be made, except as provided herein at the Sponsor's sole discretion. Sponsor reserves the right to substitute the prize or a component thereof for any reason with a prize or a prize component of equal or greater value. Sponsor reserves the right to place reasonable restrictions on the availability or use of the prize or any component thereof for any reason. Winner is responsible for all taxes and fees in any jurisdiction associated with the prize receipt and/or use. All travel arrangements relating to the prize must be made through the Sponsor or its designated agents. No difference between the actual and approximate retail values will be awarded. Choice of transportation and hotel accommodations/room size/occupancy are at the sole and absolute discretion of the Sponsor.

## **9. Entry Conditions and Release**

By entering, each entrant agrees to: (a) comply with and be bound by these Official Rules and the decisions of the Sponsor and/or the Promotion judges which are binding and final (without right of appeal) in all matters relating to this Promotion; (b) release and hold harmless the Sponsor and each of its respective parents, subsidiary, and affiliated companies, the prize suppliers and any other organizations responsible for sponsoring, fulfilling, administering, advertising or promoting the Promotion and all of their respective past and present officers, directors, employees, agents and representatives (collectively, the "**Released Parties**") from and against any and all claims, expenses, and liability, including, except where prohibited, but not limited to, negligence and damages of any kind to persons and property, invasion of privacy (under appropriation, intrusion, public disclosure of private facts, false light in the public eye or other legal theory), defamation, slander, libel, violation of right of publicity, infringement of trademark, copyright or other intellectual property rights, property damage, or death or personal injury arising out of or relating to a participant's entry, creation of an entry or submission of an entry, participation in the Promotion, acceptance or use or misuse of prize (including any travel or activity related thereto) and/or the broadcast, exploitation or use of entry; and (c) indemnify, defend and hold harmless the Released Parties from and against any and all

claims, expenses, and liabilities (including reasonable attorneys' fees) arising out of or relating to an entrant's participation in the Promotion and/or entrant's acceptance, use or misuse of prize.

For residents of the United Kingdom Sponsor does not exclude or limit liability for death or personal injury caused by its negligence or that of its employees, agents, or sub contractors or for fraud or any other act or omission, liability for which cannot be excluded under applicable law.

#### **10. Publicity**

Where prohibited Sponsor will request winner's permission to use winner's name, likeness photograph for promotional purposes.

#### **11. General Conditions**

To the extent permitted by law the Sponsor reserves the right, in its sole and absolute discretion and in consideration of the Entrants interests, to cancel, suspend and/or modify the Promotion, or any part of it (including, without limitation, these Official Rules), if any fraud, technical failures or any other factor beyond Sponsor's reasonable control impairs the integrity or proper functioning of the Promotion, as determined by Sponsor in its sole discretion. Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the entry process or the operation of the Promotion, to be acting in violation of these Official Rules or any other promotion, or to be acting in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Promotion may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision. The Sponsor reserves the right, in its sole and absolute discretion, to cancel, amend or suspend this Promotion, or to amend these Official Rules, without prior notice or obligation, in the event of any accident, printing, administrative, or other error of any kind, or for any other reason. The Sponsor reserves the right, in its sole and absolute discretion, and without prior notice, to adjust any of the dates and/or timeframes stipulated in these Official Rules, to the extent necessary, for purposes of verifying compliance by any entrant or Entry with these Official Rules, or as a result of technical problems, or in light of any other circumstances which, in the opinion of the Sponsor, in its sole and absolute discretion, affect the proper administration of the Promotion as contemplated in these Official Rules. In the event of any discrepancy or inconsistency between the terms and conditions of these Official Rules and disclosures or other statements contained in any Promotion-related materials, the terms and conditions of these Official Rules shall prevail, govern and control.

For residents of Germany: The exclusion of liability in this section 11 does not apply in case of liability for damages from injury to life, body or health due to negligent breach of duty by the Sponsor or intentional or negligent breach of duty by a legal representative or a person used to perform an obligation of the Sponsor. Furthermore, there is no exclusion of liability in Germany for other damages arising from a grossly negligent breach of duty by the Sponsor or from an intentional or grossly negligent breach of duty by a legal representative of the Sponsor or a person used to perform an obligation of the Sponsor.

#### **12. Limitations of Liability**

The Released Parties are not responsible for: (a) any incorrect or inaccurate information, whether caused by entrants, printing errors or by any of the equipment or programming associated with or utilized in the Promotion; (b) technical failures of any kind, including, but not limited to, malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (c) unauthorized human intervention in any part of the entry process or the Promotion; (d) technical or human error which may occur in the administration of the Promotion or the processing of Entries; or (e) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Promotion or receipt or use or misuse of any prize except (i) for residents of Singapore where the act has resulted from negligence on the part of the Sponsor and (ii) for residents of Hong Kong where the act has resulted in death or personal injury. For residents of the United Kingdom

If for any reason an entrant's Entry is confirmed to have been erroneously deleted, lost, or otherwise destroyed or corrupted, entrant's sole remedy is another Entry in the Promotion, provided that if it is not possible to award another Entry due to discontinuance of the Promotion, or any part of it, for any reason, Sponsor, at its discretion, may elect to hold a random drawing from among all eligible Entries received up to the date of discontinuance for any or all of the prizes offered herein. ### **13. Disputes**

Each entrant agrees that: (a) any and all disputes, claims and causes of action arising out of or connected with this Promotion, or any prizes awarded shall be resolved individually, without resort to any form of class action; (b) any and all disputes, claims and causes of action arising out of or connected with this Promotion, or any prizes awarded, shall be resolved exclusively by the appropriate United States District Court in Texas or the appropriate Texas State Court located in Collin County, Texas; (c) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Promotion, but in no event attorneys' fees; and (d) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim proven, punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. **SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE MAY NOT APPLY TO YOU.** For residents of South Africa, the Sponsor bears no responsibility concerning the quality, appropriateness and or use of any prize. FOR HONG KONG RESIDENTS ONLY: Entrants' personal data shall not be kept longer than necessary for the fulfilment of the purpose (including any directly related purpose) for which the data are (or are to be) used. Further the personal data must be used only (unless with the prescribed consent of the data subject) for the purpose for which the data were to be used at the time of collection or a purpose directly related thereto.

The Sponsor will take all steps reasonably necessary to ensure that each entrant's data is treated securely.
